- 4. PRESENTATION
 - 4.1. Cindy Hockley Grimshaw/Berwyn & District Hospital Foundation

The Grimshaw/Berwyn & District Hospital Foundation provides financial support for medical related health equipment for the hospital but cannot purchase same items for the Grimshaw Medical Clinic. Gift baskets are purchased for Doctors and staff through the Foundation funds. AHS must approve all equipment and material purchases for the hospital, where these purchases can take up to 6 months for approvals. AHS currently has a freeze on purchasing and the Foundation has had an approval in the queue since summer. The Foundation has funds that can be used and will work with AHS on a purchasing structure.

GRHARC will advocate to AHS for continued communications/collaboration with the Doctors and staff for material hospital needs and the Foundation. The Foundation would like to purchase equipment that would allow more recruits to come to our area.

ACTION: GRHARC to work with the Foundation to organize a summer BBQ for staff in 2025.
